Subject: - FACILITATING THE APPLICANTS FOR DEPOSITING OF APPLICATION FEE FOR RECRUITMENT OF JOB IN PAKISTAN POST THROUGH A.C.G-67/P.O RECEIPT INSTEAD OF POSTAL ORDERS.

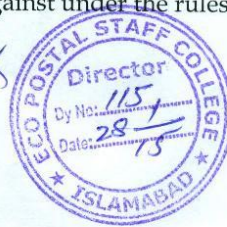
Pakistan Post has announced the vacancies position for recruitment through print media on 25-01-2015 and demanded postal order of Rs.200/- for each application. In view of shortage of postal orders, it has been decided to allow the prospective applicants for job to deposit the required fee of Rs.200/- in A.C.G-67/P.O Receipt under Head "Unclassified Receipt" in case of non availability of postal orders from post offices.

2. All Postmasters General are, therefore, directed to *ensure availability of sufficient number of A.C.G-67/ P.O Receipt Books in post offices* to facilitate the applicants to deposit the application fee.

3. The following instructions shall be issued to the post offices:

- i) Notice according to the enclosed specimen should prominently be displayed for the prospective candidates on the *Postal Order Sales Counters, General Notice Board and the main entrance of post offices* for information of availability of this facility.
- ii) The staff of the post offices to courteously extend full cooperation to the prospective candidate in depositing application fee through A.C.G-67/P.O Receipt.
- iii) All the unit officers should personally supervise to ensure its implementation.
- iv) Any post office official failing to implement of these instructions should be proceeded against under the rules by the unit officer.
